

PANRE-LA ACKNOWLEDGEMENT

I certify that I am the individual named above. I acknowledge that I have read and understand the policies and procedures provided to me when I registered for PANRE-LA. I further understand that NCCPA may update its PANRE-LA policies and procedures from time to time and that I will be bound by any updates to these policies and procedures. I acknowledge that I have read and understand the current policies and procedures and agree to comply with them. I certify that:

- I will work independently in responding to the PANRE-LA test questions. Although I may consult published reference materials such as books or online journals if time allows, my answers will represent only my own knowledge and abilities.
- I may use an internet search engine to identify published reference materials, but I may not use or rely on Al-generated content during a PANRE-LA exam session or to respond to the PANRE-LA test questions.
- I will take PANRE-LA in a location and manner in which no other individual may view or otherwise be exposed to the test items in the examination.
- I will not seek or receive assistance from other individuals when completing the PANRE-LA, discuss with or reveal to others the content of the exam questions or answers (whether before, during, or after my PANRE-LA sessions), copy answers from someone else, have another individual answer any exam question for me, or assist another in answering their own PANRE-LA exam questions.
- I will not at any time distribute, disclose, post, show, or share the exam content (including questions, answers, and rationales) with others by any means, including by discussing the exam content on social media.
- I will not copy, save, screen capture, transcribe, memorize and reproduce, or
 publish exam questions or other related content (including by sharing exam
 questions online), before, during, or after signing into the exam system, whether
 for the purpose of contributing to my own performance on the PANRE-LA, to
 assist another PA who is taking or plans to take the PANRE-LA, or to engage in
 academic discussions of the content.
- I will not, by any means whatsoever, enter or upload exam content (including
 questions, answers, and rationales) to any internet site or into any search engine
 or platform that incorporates generative AI or Large Language Models, whether
 during or after my PANRE-LA sessions, because doing so would compromise the
 security of those test items.
- I will not identify to others prior to the end of an assessment quarter the specific knowledge areas that are addressed in exam questions for that quarter nor

- inquire of others about the specific knowledge areas addressed in the exam questions for that quarter.
- I understand that if I have questions or concerns about the PANRE-LA exam content I have viewed (including questions, answers, and rationales), those questions or concerns may only be raised to NCCPA and to no other person, so as to protect the security of the PANRE-LA test. I understand that if I violate the terms of this agreement or the Code of Conduct for Board Certified and Certifying PAs and PAs with the PA-C Emeritus Designation, engage in activity that may compromise the validity, integrity, or security of this exam, or fail to cooperate in any investigation related to this agreement, my participation in the PANRE-LA may be terminated, and I may be subject to other sanctions in accordance with NCCPA's Policies and Procedures for PA Disciplinary Matters, including but not limited to revocation of board certification or revocation of eligibility for board certification.
